

USW Academic Achievement Scholarship 2018/19*

Frequently Asked Questions

The Academic Achievement Scholarship is available to EU (non UK) citizens.

1. Who is eligible?

The main points of eligibility are below however, the following FAQs clarify more detailed questions regarding eligibility.

To be eligible, you will need to:

- Be an **EU** (non UK) student liable for the EU rate of tuition fees and eligible for EU student support from the UK government
- Apply for a full time eligible bachelor honours degree at a University of South Wales campus by **25 May 2018**
- Apply for the Academic Achievement Scholarship by **29 June 2018**
- Accept our offer of a place on an eligible course on a firm basis by **13 July 2018**
- Meet or exceed the grades outlined in [Appendix A](#) , in one sitting from final high school qualifications **completed during or after summer 2016**
- Be enrolled on a full time eligible course at a University of South Wales campus at the time of payment

2. How do you apply?

Once you have applied for and been offered a place on an eligible full time course, you will be sent an email containing a link to an online application form after the 1st of February 2018. The email will be sent to the email address listed on your course application to the University. If this email address is an agent email address the please see FAQ (3) below.

3. I am an agent – how can my student apply for the scholarship?

If the student has listed your email address on their course application and you receive the email to apply for the scholarship then please ensure that you send this information to the student for completion. The application form for the scholarship **MUST** be completed by the prospective student and not the agent.

4. What qualifications are taken into consideration for the scholarship?

Prospective students must meet or exceed the grades outlined in Appendix A, in one sitting from final high school qualifications **completed during or after summer 2016**.

5. I have already achieved some or all of the qualifications outlined above before 2016, will I still be considered for the scholarship?

No, the scholarship requires prospective students to achieve or exceed the grades outlined above in one sitting **during or after summer 2016 only**.

6. How will I know if I am successful?

The Student Money Advice Team will notify students of their eligibility via their University email address by October 2018. **Please note:** the award will be confirmed in February 2019 to all students that have remained eligible for the scholarship.

7. How much is the scholarship worth?

Successful students will receive £2000 paid directly into their bank account by BACS when the award is confirmed in February 2019. **Please note:** Eligible students must be in good academic and financial standing with the University at point of payment e.g. they must not be a debtor without a payment plan and payment can only be made to a UK bank account which is held in the student's name.

8. Do I have to be enrolled on an eligible course at the time of payment?

Yes.

9. Will I receive payment in subsequent years on my course?

No, this scholarship is payable in your first year only.

10. I meet the criteria for the Academic Achievement Scholarship and another University of South Wales scholarship or bursary – can I receive more than one scholarship or bursary?

Yes.

11. I was going to apply to the University for 2018 entry but am now considering a gap year, will I still be eligible?

If you are planning to start your course in September 2019, you will need to check the details of any bursary or scholarship scheme available to new students starting in September 2019, including fulfilling the eligibility criteria relating to that scheme and making an application if necessary. Details regarding any 2019/20 scheme that might be offered are expected to be announced in summer 2018.

12. What courses are eligible?

All full time undergraduate honours degrees starting at year 0 and year 1 will be considered with the exception of the following courses:

Course Code	Course Title
B701	Bachelor of Nursing (Hons)(Adult)
B702	Bachelor of Nursing (Hons)(Child)
B703	Bachelor of Nursing (Hons)(Learning Disabilities)
B704	Bachelor of Nursing (Hons)(Mental Health)
B720	Bachelor of Midwifery (Hons)

Please note the scholarship is also not applicable to students starting a HND/HNC, CERT HE, Foundation Degree, top up year(s), NHS funded degree or non-honours degrees.

13. What happens if I transfer courses in my first year?

You will still be eligible to receive payment at the intended time if you continue to meet the eligibility criteria as outlined above.

14. I am a part time student; will I be eligible?

No. The Scholarship is only for new students starting a new full time eligible undergraduate honours degree in September 2018.

15. I am a continuing undergraduate student; will I be eligible?

No. The Scholarship is only for new students starting a new full time eligible undergraduate honours degree in September 2018.

16. I am a current student progressing onto year 2 (or 3) of a course – am I eligible?

No. The Scholarship is only for new students starting a new full time eligible undergraduate honours degree in September 2018.

17. What happens if I leave/ am suspended/ excluded from the University?

- If you leave the University before payment in February 2019, you will not be eligible to receive the scholarship payment.
- If you decide to leave the University after your payment has been made, you are entitled to keep the payment, providing the payment was not made in error.

18. If I receive an overpayment, will I have to repay it?

Yes. By accepting any payments you are agreeing to repay any amounts that are subsequently found to be overpayments or incorrect payments. Any overpayments that are not repaid will result in the debt being referred to the University Finance department and the appropriate action taken.

19. Is the scholarship repayable?

No, there is no requirement for you to repay the Scholarship, unless payment has been made in error, in which case please see the FAQ (18) above regarding overpayments.

20. I want to study a University of South Wales course at an accredited/associate college. Will I be entitled to this Scholarship?

No, however you may be eligible for any scholarships or bursaries offered by the college. Please contact the accredited/associate college direct.

21. Can I appeal against any decisions regarding my eligibility?

All students have the right to appeal decisions made by the Student Money Advice Team regarding their eligibility for the Academic Achievement Scholarship.
